NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On January 18, 2018, NY State of Health (NYSOH) issued an eligibility determination notice stating that you did not qualify for health insurance through NYSOH.

Also on January 18, 2018, you spoke with NYSOH and requested an appeal insofar as your eligibility to enroll in health insurance through NYSOH. Further, you requested to be contacted at [REDACTED]

On March 2, 2018, NYSOH issued a Notice of Telephone Hearing, advising you that the hearing you requested was scheduled for March 23, 2018, at 10:00 am.

On March 23, 2018, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you five times between 10:00 am and 10:30 am, using the telephone number stated above and the number listed in your NYSOH account. You did not answer on any attempt.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
