## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did the NY State of Health properly determine that your children's enrollment in their Child Health Plus plan was effective January 1, 2018?

## Procedural History

On November 6, 2017, NY State of Health (NYSOH) issued an eligibility determination notice, based on your November 5, 2017 application, stating that your children were eligible to enroll in Child Health Plus with a \$15.00 monthly premium, effective December 1, 2017. The notice further directed you to pick a health plan for your each of your children.

On December 8, 2017, NYSOH issued a plan enrollment notice, based on your plan selection for your children on December 7, 2017, confirming their enrollment in a Child Health Plus plan as of January 1, 2018.

On December 19, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin December 1, 2017.

On March 1, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your children's enrollment start date.
- 2) You submitted an application to NYSOH for financial assistance on November 6, 2017.
- 3) You testified that this was the first time you applied through NYSOH because you had previously enrolled your children in a Child Health Plus plan directly through the health plan.
- 4) You testified that you received the November 6, 2017 notice, but did not realize that you were required to select a plan because you were renewing their coverage. The November 6, 2017 eligibility determination notice states on pages one and two that your next step was to pick a health plan for your children. The notice advised you that you would receive written confirmation from NYSOH once you selected a plan.
- 5) You testified that you were first aware that you had to select a plan for your children when [REDACTED] doctor advised you that she did not have coverage in December 2017.
- 6) According to your NYSOH account and your testimony, you enrolled your children into a Child Health Plus plan on December 7, 2017.
- 7) You testified that you need your children's Child Health Plus plan to begin on December 1, 2017, because you have outstanding bills for medical services rendered in December 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## Applicable Law and Regulations

### Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer

resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your children's enrollment in their Child Health Plus plan was effective January 1, 2018.

You submitted an application to NYSOH for financial assistance on November 6, 2017. You testified that this was the first time you applied through NYSOH because you had previously enrolled your children in Child Health Plus directly through the health plan. Although you received the November 6, 2017 notice, you testified that you did not realize that you were required to select a plan because you were renewing their coverage. However, the November 6, 2017 eligibility determination notice clearly states on pages one and two that your next step was to pick a health plan for your children. The notice advised you that you would receive written confirmation from NYSOH once you selected a plan. Therefore, NYSOH properly advised you that you were required to select a plan for your children in order for their coverage to begin.

The record reflects that you contacted NYSOH on December 7, 2017, and enrolled your children into a Child Health Plus plan that day with an enrollment start date of January 1, 2018.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected a plan for your children on December 7, 2017, their enrollment properly began on the first day of the month following December 2017; that is, as of January 1, 2018.

Therefore, the December 8, 2017 plan enrollment notice stating that your children's enrollment in their Child Health Plus plan was effective January 1, 2018, is correct and must be AFFIRMED.

## **Decision**

The December 8, 2017 plan enrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your children's eligibility for Child Health Plus or enrollment start date in their Child Health Plus plan.

The effective date of your children's Child Health Plus plan is January 1, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

This decision does not change your children's eligibility for Child Health Plus or enrollment start date in their Child Health Plus plan.


The effective date of your children's Child Health Plus plan is January 1, 2018.
