On December 6, 2017, NY State of Health (NYSOH) issued an eligibility determination notice stating that you were no longer eligible for health insurance through NYSOH as of January 1, 2018, because you did not provide documentation to confirm your household's income.

Also on December 6, 2017, NYSOH issued a disenrollment notice stating that your coverage would end on December 31, 2017, because you were no longer eligible to enroll in health insurance coverage.

On January 5, 2018, you spoke with NYSOH's Account Review Unit and requested an appeal insofar as the discontinuance of your health insurance coverage through NYSOH.

On January 17, 2018, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective January 1, 2018.

Also on January 18, 2018, NYSOH issued an enrollment notice confirming that as of January 17, 2018, you were enrolled in a Medicaid Managed Care (MMC) plan with an enrollment start date of March 1, 2018.

On March 27, 2018, you had a scheduled telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. At the hearing, you stated that your

Medicaid coverage had been reinstated and withdrew your appeal on the record through sworn testimony

Accordingly, we are dismissing your appeal.

If You Think Your Appeal Should Not Be Dismissed

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.
