NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On January 23, 2018, NY State of Health (NYSOH) issued a notice of enrollment, stating that your enrollment in an Essential Plan would start March 1, 2018. You appealed insofar as your plan did not begin February 1, 2018.

On February 9, 2018, NYSOH issued a notice of enrollment stating that your Essential Plan would start as of February 1, 2018.

On March 21, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath. The Hearing Officer agreed to adjourn your hearing to March 23, 2018 at 10:00 A.M in order to allow you time to call your health plan and confirm the start date of your Essential Plan.

On March 23, 2018, you had a scheduled telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During the hearing, you waived your right to the 15-day formal notice of hearing. While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you confirmed that your coverage with your Essential Plan was uninterrupted, specifically that you had coverage in February 2018 as stated in the February 9, 2018 enrollment confirmation notice.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
