



IT'S TIME TO RENEW YOUR HEALTH INSURANCE

The renewal period for health insurance through NY State of Health starts today. **To stay covered in 2023, you need to renew your health insurance.** You'll need to act no later than December 15 to have your coverage begin on January 1, 2023.

Here's what you need to do:

1) Read your Renewal Notice and Follow the Instructions

You should have received either a NY State of Health Renewal Notice by mail or an email telling you to read the Renewal Notice online. It explains:

- What health insurance program you qualify for in 2023
- Your cost for health insurance in 2023
- Actions you should take, if any, to renew your health insurance for 2023 and avoid gaps in coverage

2) Tell Us if Something Has Changed in Your Life

Has your income changed? Has your family size changed? Have you moved to a new home? You need to tell us these updates.

3) Contact Us If You Have Questions about Renewing Your Coverage

We're here to help. Call the Customer Service Center or contact a [certified enrollment assistor](#) if you have questions. **Help is available in your own language.**

4) Pick a Health Plan

Prices and participating health care providers can change each year, so you may want to take another look at your plan options.

The New York State Department of Health and the Centers for Disease Control and Prevention (CDC) recommend individuals 12 and older get the new bivalent COVID-19 booster. All New Yorkers, including children 6 months of age and older, should stay up to date with all recommended vaccine doses. Booster doses will maximize your protection and are free and available statewide. If you have questions, talk to your healthcare provider or vaccine administrator.
