Dear Assistor:

We are writing to provide follow up information on Unemployment Insurance Benefits (UIB) under the Pandemic Unemployment Compensation (previously called the Pandemic Relief Payment).

Please find attached instructions for <u>who</u> should include their Pandemic Unemployment Compensation payment as income in their NY State of Health application and how to do it.

How to enter the additional Pandemic Unemployment Compensation – Coronavirus (COVID-19) (Previously called the Pandemic Relief Payment)

Instructions on <u>WHO</u> should report Pandemic Unemployment Compensation as income in NY State of Health

Both current and new UIB recipients may receive two (2) payments from the New York State Department of Labor for Unemployment Insurance Benefits (UIB). Not everyone applying for health insurance coverage through NY State of Health should enter the Pandemic Unemployment Compensation payments as income.

Consumers should not report any income from Pandemic Unemployment Compensation until they have received a determination from the Department of Labor. Please review the additional information below once a determination for the Pandemic Unemployment Compensation has been made.

Consumers should include Pandemic Unemployment Compensation as income and follow the instructions starting on page 2, IF they:

- Do not have children* in their household AND
- Their yearly income is more than \$25,520 for a single individual or \$34,480 for a couple.

If a consumer does have children* in their household **OR** the expected yearly income is less than \$25,520 for a single individual or \$34,480 for a couple, **DO NOT** report Pandemic Unemployment Compensation as income.

*The term children above is as defined by Medicaid rules. This means a child under 19 years old, or 19 and 20 if a full-time student.

ONLY follow the instructions below AFTER REVIEWING THE GUIDENCE ABOVE and determining that the consumer should add their Pandemic Unemployment Compensation to their NY State of Health application as income.

- 1. Do not enter the Pandemic Unemployment Compensation on the "Benefit Income" screen. The "Benefit Income" screen should <u>only</u> be used to estimate or report the consumer's regular UIB payment, which will equal \$504 per week or less.
- 2. Use the Additional Income screen to enter the consumer's Pandemic Unemployment Compensation as shown below.
 - Click "Yes."
 - Click "Add additional income" for the applicable consumer.
