Adding an Agency in the Broker Portal

Brokers may have multiple agencies under which they submit business. In the NY State of Health Broker Portal, adding a new agency is easy. Simply start by signing in to the NYSOH Broker Portal.

1. Log in to <u>https://nystateofhealth.ny.gov</u>. Click **Brokers** in the upper right-hand corner.



2. On the Broker Portal sign-on page, click the **Broker Sign In** button with the newly created NY.Gov ID.



3. Once on the *Overview* screen, click the **My Profile** tab at the top of the screen. From the top of the *My Profile* screen, scroll down to the bottom of the page. Under *Agency Affiliation*, all agencies already affiliated will appear, if applicable.
