### Understanding the New Financial Assistance

- The American Rescue Plan was signed into law on March 11, 2021. It includes new and larger financial assistance for New Yorkers enrolling in health insurance through NY State of Health.
- This financial assistance is available now to **current and new enrollees**, including **higher-income individuals for the first time**.
- Keep an eye out for notices and emails from NY State of Health alerting you of what you need to do.

# The **American Rescue Plan** Lowers the Cost of Health Coverage for most New Yorkers

## What You Need to Do:

### ***If you are already enrolled in a plan through NY State of Health and receive financial assistance:***

- You are now eligible for more financial assistance.
- NY State of Health sent you a letter in early April with your new, larger tax credit amount.
- NY State of Health automatically increased your tax credit amount for you. You can make changes by logging into your NY State of Health account, contacting your enrollment assistor, or calling 1-855-355-5777.

### ***If you started a NY State of Health application but did not enroll in a health plan:***

- If you were told that you were eligible for financial assistance, you are now likely eligible for more. Log back into your NY State of Health account now and check to see if you are eligible for larger tax credits, then shop for and select a plan.
- If you were previously told that you were not eligible for financial assistance, NY State of Health may have sent you a more recent notice informing you that you are. Log back into your NY State of Health account and check to see if you are eligible for tax credits, then shop for and select a plan.

### ***If you are already enrolled in a NY State of Health plan and do not receive financial assistance:***

- You may now be eligible for premium tax credits.
- If you are eligible, NY State of Health will send you a letter stating your new tax credit amount. Instructions on how to apply your tax credit will be available at <https://info.ny-stateofhealth.ny.gov/AmericanRescuePlan>

### ***If you are not enrolled in a plan through NY State of Health and never started an application:***

- Apply now at [nystateofhealth.ny.gov](https://nystateofhealth.ny.gov) to find out what you're eligible for.
- Most New Yorkers qualify for low cost or free coverage.
