

## **Countdown to 2018 Open Enrollment Period Deadline!**

**With the Open Enrollment Period closing soon on January 31<sup>st</sup>, we're continuing outreach efforts across the state in locations convenient to consumers. With more than 200 events scheduled, here are a few of the places we'll be:**

- **NY State of Health Awareness Day at NY State Parks** – On January 20<sup>th</sup>, assistors will be stationed inside warming huts at approximately a dozen state parks to educate consumers about the Marketplace and the January 31<sup>st</sup> enrollment deadline.
- **Public Library Events** – Two dozen enrollment events are scheduled at libraries in NYC during the month of January. NY State of Health representatives also will be presenting at various libraries throughout upstate communities.

## **NEWS**

### **Enrollment Continues to Climb!**

Enrollment for 2018 continues to outpace enrollment from 2017. Higher enrollment shows consumer demand for the affordable, quality health plans offered by the Marketplace.

### **Enrollment Highlights as of January 16, 2018:**

- 243,600 consumers have enrolled in a Qualified Health Plan (QHP), reflecting an increase of nearly 15,000 since last reported in mid-December and exceeding enrollment levels at the end of open enrollment in 2017.
- Among the QHP enrollees, 54,700 are new and 188,900 are returning customers.
- Enrollment in the popular Essential Plan for lower income New Yorkers reached 726,300, reflecting an increase of more than 10,000 people since last reported in mid-December.

## Premium Tax Credits and Form 1095-A

Over the next few weeks, consumers who were enrolled in a QHP in 2017 will receive an IRS Form 1095-A from NY State of Health, the forms are posted to consumer accounts and sent by mail. Consumers who were enrolled in QHPs need this form to file 2017 federal tax returns. The brochure, *A Guide to Form 1095-A*, is available on our website and for distribution. Additionally, there are FAQs available in English and 8 other languages that can help consumers with their 1095A forms.
