**It's Almost Time for Open Enrollment 2019
Get Ready to Get New Yorkers Covered!**

Open Enrollment Begins November 1, Renewals Begin November 16, 2018

Over 95 percent of Marketplace enrollees will see no cost increase in 2019, and Qualified Health Plan enrollees not eligible for tax credits are encouraged to shop for lower cost plan options.

Once again, New York is giving consumers more time to make important health coverage decisions by extending the final deadline for Qualified Health Plan enrollment to January 31, 2019, well beyond the deadline set by the Federal government.

Thank you for all of your hard work in getting New Yorkers covered and helping to make Open Enrollment a success! Read on to learn some of the other exciting things happening at the Marketplace during our 6th Open Enrollment Period.

Email Messages Prep Consumers for Enrollment

The Marketplace continues its successful consumer email campaign for 2019 in both English and Spanish. A series of email messages will go out to consumers before and during the enrollment period. Emails will include:

2019 Health Plan Participation

- 12 insurers will offer Qualified Health Plans (QHP)
- 16 insurers will offer the Essential Plan
- 9 insurers will offer 2,080 products through New York's Small Business Marketplace (SBM) giving employers more options to choose from than ever before.

Games and Giveaways Spark Conversation with Consumers

Games, like Plinko, and giveaways bring consumers to the table at events and spark conversations about the quality low-cost health insurance available through the Marketplace. Often these interactions lead to appointments and enrollments. This year, cell phone wallets have been added to our menu of items! Easier Access to Tax Credits For Small Businesses

The NY State of Health Small Business Marketplace got a boost in employer participation as a result of some changes made at the federal level that make offering health insurance to employees easier for small employers. The number of participating employers in the Small Business Marketplace has increased by over 300 percent since the changes in April and now exceeds 9,000. Today, there are nine insurers offering more than 2,000 products through New York's Small Business Marketplace.



Effective in April 2018, eligible small employers access tax credits by completing a short application at nystateofhealth.ny.gov/employer and enroll in Marketplace-certified Qualified Health Plans directly through insurers. Small businesses have more health plan choices than ever before, and can receive the Small Business Health Care Tax Credit, if qualified.

NY State of Health will launch a statewide small business-focused marketing effort including new materials, partnerships with state agencies, and digital and print advertising. Outreach to the broker community is ongoing through webinars and in person meetings.
