Small Business Marketplace: Value for Small Employers

Choice

• Employers and employees regard expanded choice as a key advantage to using the Marketplace.

Administrative Simplicity

•The Marketplace provides monthly billing to employers along with other administrative simplifications.

Tax Credits

•The Marketplace will be the exclusive place to access small business tax credits in 2014.

Contribution Options

•Many business owners believe this feature helps predict costs.

No Minimum Participation or Contribution

•NYSOH does not require a minimum number of employees be enrolled in a QHP nor require an employer to contribute an amount towards premium.

Small Business Marketplace Web Portal Enhancements during 2014

- Enhanced flexibility to allow changes in open/edit/retro periods
- Added COBRA enrollment functionality
- Streamlined employment classes functionality
- Added new hire waiting period criteria
- Expanded dental coverage tiers from 2 to 5 (including stand-alone pediatric dental)
- Moved domestic partner & qualified religious organization riders to employer level
- Employer & employee portal account overview display enhancements

Demonstration of Employer Group Renewal Process

Scenario 1

Employer Group: Time Clocks

Current Plan Year effective date: January 1, 2014 – December 31, 2014

Prospective Plan Year (Renewal): January 1, 2015 – December 31, 2015

Assumption: Time Clocks has elected to renew their participation in the SBM for 2015.

Scenario will demonstrate: Employer group wants to add an additional health plan carrier to replace Oxford and add Dental coverage options as well.



Demonstration of Employee Renewal Process

Scenario 2

Employer Group: Time Clocks

Employee: Amy Smith

Current Plan Year effective date: January 1, 2014 – December 31, 2014
Prospective Plan Year (Renewal): January 1, 2015 – December 31, 2015
Assumption: Amy Smith is enrolled in an Oxford plan for 2014.
Scenario will demonstrate: Employee's selection of a new plan for 2015



Demonstration of Employer Group Renewal Process

Scenario 3

Employer Group: Din Warehouse

Current Plan Year effective date: January 1, 2014 – December 31, 2014

Prospective Plan Year (Renewal): January 1, 2015 – December 31, 2015

Assumption: Din Warehouse has elected to renew their participation in the SBM for 2015 but wants to make changes to their Employment Classes.

Scenario will demonstrate: Employer group changes the name of one Employment Class and re-assigns a newly promoted employee into a different Class.



Demonstration of Employee Renewal Process

Scenario 4

- **Employer Group:** Din Warehouse
- **Employee:** Tom Robertson

Current Plan Year effective date: January 1, 2014 – December 31, 2014

Prospective Plan Year (Renewal): January 1, 2015 – December 31, 2015

Assumption: Tom Robertson is enrolled in an NSLIJ Platinum plan for 2014. There is no change to the NSLIJ Platinum plan for 2015.

Scenario will demonstrate: Employee does not want to make any enrollment or plan changes; renewed enrollment in NSLIJ Platinum plan for 2015.

Broker Administrative Guide




NY State of Health has developed an administrative guide to assist brokers with enrollments on the Small Business Marketplace.


