Y'adwuma no fa baako nso ne sε yε bε dwene ho, sε wo wɔ ho kwan sε wo bε twε wo din wɔ aban dwumadie, te sε Medicaid ne Child Health Plus ase. Sa dwumadie yi ma wo kwan ma wo nya apɔwmuden so hws nneɛma ma wo anaa wo mma a wo ntua hwee-anaa abuɔ-fo-so.

Sε yε be tumi ayε yεn adwuma a, εωc sε NY State of Health si gynae na bebree, na wɔmo hwε wo tebea, gyinabea wɔ mmra a εhwε apɔwmuden dwumadie yi εni so. Etɔ dabi a wo mpene yεn nsusui no so. Εba no saa a, wo be tumi asere sε yεn dwene ho biom, na yεn sesa y'adwene. Ye frε saa abisa ade yi “appeal”.

Nsusui a wɔ betumi aye ho appeal

- Nsusui a ԑkyerɛ sɛ mmra kwan so no, wo nni ho kwan sɛ wo bɛ tɔ apɔwmu-den ho banbɔ nhyehyɛyɛ wɔ gua ne so ama wo anaa w'abusua. Ebi ne sɛ: Wo nte New York Kuro ne so, anaa wo da afiease.
 - Nsusui a ԑkyerɛ sɛ wo nni nneɛma a ɛwɔ sɛ wo wɔ ansana w'atumi anya Amerika Aban mmoa de atua apɔwmuden ho banbɔ nhyehyɛye a yɛ ton wɔ Gua ne so ho bi.
 - Sɛ wo bisa sika mmoa a, nsusui a ԑkyerɛ sɛnea ɛwɔ sɛ bosome biara wo tua.
 - Nsusui a ԑkyerɛ sɛ mmra kwan so no, wo nni ho kwan ma sɛ wo bɛ nya Medicaid anaa Child Health Plus.
 - Nsusui a ԑkyerɛ sika dodow a ɛwɔ sɛ wo tua ma Child Health Plus nhyehyɛe, sɛ wo mma wɔ saa dwumadie ho kwan a.

Ma ID a εwɔ wo ho nseм a y'aboa ano wɔ Agua ne so no, ne da ya twεrε wɔ krataa a wo nya fri yεn hɔ, a ya kyεrε yεn nsusui no a wo pεsε wo yε ho appeal no, anaa wa wo da ne wo social sekuriti nɔma, anaa nkrataa afoforɔ a εkyεrε sε εyε wo, sε w'ɔ anya krataa biara enfri yεn ho. Wo bε hunu wo ho nseм a y'aboa ano wɔ Agua ne so ID wɔ aguasofoo krataa no soro. “AC” na εhyε ase.

Wo betumi ayε yεn nsusui no ho appeal, nna 60 mu a wo nsa ka krataa no. Na nso, sε wo nya nkaebɔ krataa no, na nna 10 twa mu ansana wo bε serε appeal no a nhyehyεe no bε gyae adwuma yε.

Sε wo wɔ apɔwmuden nhyehyεe foforɔ a wo tɔ no wɔ Gua ne so a...

Wo bε ka w'asem, akyerε yen nea εnti a εse se yε sesa yεn adwene. Ewɔ se wo de fax anaa krataa mane yεn nneεma wo de bε taa w'asem no akyire. Adwumayεnii panyin a c'nte w'asem no da, εbe kyεrε n'adwene wɔ ho.

Obε kuta wo Nhwehwεε krataa no a wo twεrε kɔ Guaso hɔ no, ne nkrataa ne nneεma wo de ka wo appeal no ho mane yεn no. Ewɔ se opanyin a c'tie asem no twe asem a mo ka nyinaa gu ade so. - Opanyin no a obε tie asem no bε frε wo ne nipa afoforɔ biara cba abε ka asem no bie. Ewɔ se mo tie telefon no wo babbia ho yε din.
- Wo bεtumi ama obiara wopε atena hɔ bi mmere a mo ka asem no wɔ telefon so no, na wɔmo ε tumi aboa ma waka w'asem - obi a cωc w'abusua mu, adamfo, okamafo. Se okamafo boa wo a, anaa obi foforɔ na εka w'asem no ama wo mmere a yε tie asem no a, yε bε hia krataa, anaa Ananmusifo Krataa a εkyεrε se wo na wa fa wɔmo, εwɔ wo nsem a ya boa ano wɔ Guaso hɔ no mu, ansana da yε tie asem no aduru. Wobε nya Ananmusifo Krataa no bi wɔ [ha](#). Guaso Dwuma nso bε tumi ama obi abε gyina mu ama wɔmo, mmere asem no kɔso no.
