Y'adwuma no fa baako nso ne se ye be dwene ho, se wo wɔ ho kwan se wo be twerɛ wo din wɔ aban dwumadie, te se Medicaid ne Child Health Plus ase. Sa dwumadie yi ma wo kwan ma wo nya apɔwmuden so hwe nneema ma wo anaa wo mma a wo ntua hwee-anaa abuo-fo-so.

Se ye be tumi aye yen adwuma a, ewɔ se NY State of Health si gynae na bebre, na womo hwe wo tebea, gynabea wɔ mmra a ehwe apɔwmuden dwumadie yi eni so. Ẹtɔ dabi a wo mpene yen nsusui no so. Ẹba no saa a, wo be tumi asere se yen dwene ho biom, na yen sesa y'adwene. Ye fre saa abisa ade yi "appeal".

Nsusui a wɔ betumi aye ho appeal

- Nsusui a ekyere se mmra kwan so no, wo nni ho kwan se wo be tɔ apɔwmuden ho banbɔ nhyehyẸe wɔ gua ne so ama wo anaa w'abusua. Ebi ne se: Wo nte New York Kuro ne so, anaa wo da afiease.
- Nsusui a ekyere se wo nni nneema a ewɔ se wo wɔ ansana w'atumi anya Amerika Aban mmoa de atua apɔwmuden ho banbɔ nhyehyẸe a ye ton wɔ Gua ne so ho bi.
- Se wo bisa sika mmoa a, nsusui a ekyere senea ewɔ se bosome biara wo tua.
- Nsusui a ekyere se mmra kwan so no, wo nni ho kwan ma se wo be nya Medicaid anaa Child Health Plus.
- Nsusui a ekyere sika dodow a ewɔ se wo tua ma Child Health Plus nhyehyẸe, se wo mma wɔ saa dwumadie ho kwan a.

- Nsusui a ekyere se wo nni kwan se wo be twere wo din wo Gua ne so na w’anya banbo nhyehyee, mmerɛ a ye frɛ no “special open enrollment period”.
- Sɛ Agua no, twe wo din twere no ko akyire. Sɛ abia: Nna 45 mu a anka esɛ wo nya wo nya nkaebo krataa a ebe kyere se mmra kwan so wo wo Medicaid mmoa ho kwan a, wo anya nkaebo no.
- Nsusui a esesa nsusui biara a Guaso dwumakuo no aye dedaw.
- Nsusui a ekyere se wo appeal no ngyina.

1. Ma ID a ewo wo ho nsem a y’aboa ano wo Agua ne so no, ne da ya twere wo krataa a wo nya fri yen ho, a ya kyere yen nsusui no a wo pese wo ye ho appeal no, anaa wa wo da ne wo social sekuriti noma, anaa nkrataa afoforo a ekyere se eye wo, se wo anya krataa biara enfri yen ho. Wo be hunu wo ho nsem a y’aboa ano wo Agua ne so ID wo aguasoforo krataa no soro. “AC” na ehye ase.
2. Mane ko **nna 60 mu a wo nsa aka Nkaebo Krataa yi.**
3. Ka nea enti a wo dwene se ewo se ye sesa y’adwene.
4. Fa nneema wo de taa w’asem no akyire a, fa fax anaa mai mu bre yen.
5. Ka pefee se w’apɔwmuden nsem nti no, wo pese wo ye wo appeal no ntem-ye kwan so.

Obe kuta wo Nhwewwee krataa no a wo twerε ko Guaso ho no, ne nkrataa ne nneema wo de ka wo appeal no ho mane yen no. Ewo se opanyin a o'tie asem no twe asem a mo ka nyinaa gu ade so. Mmere beberee no beye nnawotwe mmienu anaa mensa mu a w'atie asem no awie ye no, Panyin no a no be san atie asem no a w'atwe ato ho no, ne wa ye n'adwene. - Opanyin no a obe tie asem no be fre wo ne nipa afoforo biara o'ba abe ka asem no bie. Ewo se mo tie telefon no wo babia ho ye din.
- Wo betumi ama obiara wope atena ho bi mmere a mo ka asem no wo telefon so no, na womo ε tumi aboa ma waka w'asem - obi a owo w'abusua mu, adamfo, okamofo. Se okamofo boa wo a, anaa obi foforo na eka w'asem no ama wo mmere a ye tie asem no a, ye be hia krataa, anaa Ananmusifo Krataa a ekyere se wo na wa fa womo, εwo wo nsem a ya boa ano wo Guaso ho no mu, ansana da ye tie asem no aduru. Wobe nya Ananmusifo Krataa no bi wo [ha](#). Guaso Dwuma nso be tumi ama obi abe gyina mu ama womo, mmere asem no koso no.

- Wo be tumi amane nkrataa ako Guaso ho, anaa wo be ma nkrofoɔ a wɔmo tie asem no a wɔmo taa w'akyire no amane nkrataa ako Goaso.
- Adwumayenii no a ɔtie asem no be tumi abisa wo Guaso ho Ananmusifo no anaa W'ananmusifo no nsem.
- Guaso ho ananmusifo no be tumi abisa wo anaa wo nanmusifo no nsem, na wo anaa wo nanmusifo no be yi n'ano.

- Se wa sere se ye ntie w'asem no, na da a ya'hye no ye da wo ntumi n'kasa wo telefon so a, fre adetofuo som no ntem ara na bisa se yen sesa w'asem tie no ko da foforo.
- Se w'amba asem tie no a, ye be bu wo appeal no agu. Se wo tumi twere ema Guaso ho fo nea enti a w'antumi ambe na aba wo mo ansana nna 30 mu a ye mane wo krataa a ekyerɛ se y'abu wo appeal no agu aduru a, Guaso ho fo no be tumi ahyɛ da foforo na wɔmo atie asem no.
- Ewo se opanyin no a ɔtie asem no etwe asem no nyinaa gu ho. Wo wo ho kwan se wo be tie asem a ya twe agu ho no nyinaa, ahwe nneema obiara de ba asem no ase, nea ya twe anaa ya twere ato ho.
