On March 20, 2014, the Marketplace prepared a preliminary eligibility determination in your case. The eligibility redeterminations issued on April 18, 2014 and May 1, 2013 were consistent with the March 20, 2014 preliminary determination.

On April 4, 2014, you appealed the preliminary determination.

The Marketplace scheduled a telephone hearing on your appeal request and on April 24, 2014, sent you a notice to tell you that a Hearing Officer would call you at about 9:00 a.m. on May 14, 2014.

Between 9:00 a.m. and 9:40 a.m. on May 14, 2014, the Hearing Officer placed three calls to the telephone number that you gave the Marketplace but was unable to reach you. Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The eligibility determinations issued on April 18, 2014 and May 1, 2013 continue in effect.

If You Think Your Appeal Should Not Be Dismissed

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
