On May 20, 2014, you first applied for health insurance through the Marketplace by paper application.

The Marketplace received your modified electronic application on July 30, 2014.

On July 31, the Marketplace issued a notice of eligibility determination in your case stating that you were eligible to enroll in a qualified health plan through the Marketplace but you were not eligible to receive tax credits or cost sharing reductions because you were already enrolled in or eligible for minimum value employer sponsored insurance (ESI).

On August 4, 2014, you spoke with the Marketplace Customer Service Unit and appealed that determination.

The Marketplace scheduled a telephone hearing on your appeal request and, on August 15, 2014, sent you a notice to tell you that a Hearing Officer would call you at 10:30 a.m. on September 10, 2014.

Between 10:30 a.m. and 11:00 a.m. on September 10, 2014, the Hearing Officer placed three calls to the telephone number that you gave the Marketplace but was unable to reach you. Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The Marketplace's July 31, 2014 eligibility determination continues in effect.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
