On January 2, 2015, the Marketplace prepared a preliminary eligibility determination stating that you, your spouse, and your children were eligible to purchase a qualified health plan at full cost through New York State of Health.

On January 2, 2015, you spoke to the Marketplace's Account Review Unit and appealed that determination.

On January 3, 2015, the Marketplace issued an eligibility determination stating that you, your spouse, and your children were eligible to purchase a qualified health plan at full cost through New York State of Health effective February 1, 2015.

On February 5, 2015, you had a telephone hearing with a Hearing Officer from the Marketplace's Appeals Unit. At the hearing you confirmed that you no longer wanted to pursue your appeal and withdrew your appeal on the record through sworn testimony.

Accordingly, we are dismissing your appeal.

### **How does this Dismissal Affect Your Eligibility?**

The Marketplace's January 3, 2015, eligibility determination continues in effect.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
