NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On January 7, 2015, you submitted an application to the Marketplace in which you attested to an expected yearly income of \$24,039.34.

On January 8, 2015, the Marketplace issued a notice of eligibility determination based on your January 7, 2015 application. It found that you were eligible to enroll in a qualified health plan (QHP); eligible to receive an advance premium tax credit (APTC) of up to \$212.00 per month; and, if you selected a silver-level plan, cost-sharing reductions (CSR), with such coverage beginning February 1, 2015. It also found you ineligible for Medicaid coverage. Your son, [REDACTED] was found eligible for Medicaid coverage as of January 1, 2015

On January 12, 2015, you spoke with the Marketplace's Account Review Unit and appealed the January 8, 2015 eligibility determination insofar as it found you eligible for up to \$212.00 per month in APTC.

On January 23, 2015, the Marketplace issued a Notice of Telephone Hearing to advise you that the hearing you requested was scheduled for February 9, 2015 at 1:00pm.

On February 9, 2015, you failed to appear by telephone for your scheduled hearing. An impartial Hearing Officer attempted to contact you at the phone number you provided to the Marketplace on three separate occasions between 1:01 pm and 1:32pm. We were unable able to reach you.

Accordingly, we are dismissing your appeal.

How Does this Dismissal Affect Your Eligibility?

The Marketplace's eligibility determination issued on January 8, 2015 remains in effect.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
