On January 23, 2015, the Marketplace prepared a preliminary eligibility redetermination that your two children are eligible for Medicaid Fee for Service effective January 1, 2015, and for Medicaid Managed Care as of March 1, 2015.

That same day, you appealed the Medicaid Fee for Service determination and requested that your children have continuous coverage with Hudson Health Plan, Inc. a Medicaid Managed Care plan.

On January 24, 2015, the Marketplace issued a notice of eligibility redetermination and a notice of enrollment that were consistent with the January 23, 2015 preliminary eligibility redetermination.

The Marketplace scheduled a telephone hearing and sent you notice on February 11, 2015, telling you that a Hearing Officer would call you on March 2, 2015 at about 10:00 a.m.

On March 2, 2015, a Hearing Officer from the Marketplace's Appeals Unit contacted you to conduct the telephone hearing. You requested that it be adjourned and the Hearing Officer agreed to call you back at 10:30 a.m. Between 10:30 a.m. and 10:45 a.m. on March 2, 2015, the Hearing Officer placed three calls to the primary telephone number that you gave the Marketplace but was unable to reach you. Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The Marketplace's January 24, 2015 notice of eligibility redetermination continues in effect.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
