NOTICE OF DISMISSAL – FAILURE TO APPEAR

On August 6, 2014, the Marketplace issued an eligibility determination notice that stated you, your child, and your wife's insurance coverage through Medicaid would begin August 1, 2014.

On February 19, 2015, you requested an appeal regarding the effective date of your Medicaid coverage.

On March 11, 2015, the Marketplace issued a Notice of Telephone Hearing to advise you that the hearing you requested was scheduled for April 2, 2015 at 3:00 p.m.

Between 3:00 p.m. and 3:30 p.m. on April 2, 2015, a Hearing Officer called the telephone number that you gave the Marketplace. The Hearing Officer placed three calls to that telephone number but was unable to reach you. Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

On January 29, 2015, an eligibility redetermination notice was issued and remains in effect.

You and your wife remain eligible for up to \$92.00 in advance premium tax credit. Your son remains eligible to enroll in Child Health Plus with a \$45.00 per month premium.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
