On February 8, 2015, the Marketplace issued a disenrollment notice that stated you were no longer eligible to enroll in health insurance through New York State of Health. It also stated that your coverage with your insurance plan would end effective February 28, 2015.

On February 19, 2015, you spoke with the Marketplace's Account Review Unit and appealed that notice insofar as it did not terminate your coverage effective February 1, 2015.

On March 12, 2015, the Marketplace issued a Notice of Telephone Hearing to advise you that the hearing you requested was scheduled for April 7, 2015 at 11:00 a.m.

Between 11:00 a.m. and 11:30 a.m. on April 7, 2015, a Hearing Officer placed three calls to the telephone number that you gave the Marketplace, but was unable to reach you. Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### How does this Dismissal Affect My Eligibility?

The Marketplace's February 8, 2015 disenrollment notice continues in effect.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
