NOTICE OF DISMISSAL – FAILURE TO APPEAR

On January 17, 2015, the Marketplace issued an eligibility determination notice that stated you and your husband were conditionally eligible to receive up to \$622.00 in advance premium tax credit (APTC) per month and newly conditionally eligible to receive cost sharing reductions if you enrolled in a silver level health plan. This eligibility was effective March 1, 2015.

On February 20, 2015, you requested an appeal of that eligibility determination insofar as it began the eligibility for APTC on March 1, 2015.

On March 13, 2015 the Marketplace issued a Notice of Telephone Hearing to advise you that the hearing you requested was scheduled for April 10, 2015 at 9:00 a.m.

Between 9:00 a.m. and 9:30 a.m. on April 10, 2015, a Hearing Officer called the telephone number that you gave the Marketplace. The Hearing Officer placed three calls to that telephone number but was unable to reach you. Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The January 17, 2015 eligibility determination notice remains in effect.

You and your husband remain conditionally eligible to receive up to \$622.00 per month in APTC and are newly conditionally eligible for cost sharing reductions if you enroll in a silver level health plan. This eligibility is effective March 1, 2015.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
