On February 11, 2015, the Marketplace issued a disenrollment notice stating that your insurance coverage with Hudson Health Plan, Inc. would end effective February 28, 2015.

On February 25, 2015, you spoke to the Marketplace Account Review Unit and appealed the February 11, 2015 disenrollment notice.

On April 20, 2015 you had a telephone hearing with a Hearing Officer from the Marketplace's Appeals Unit. At the hearing you confirmed that you no longer wanted to pursue your appeal and withdrew your appeal on the record through sworn testimony.

Accordingly, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The Marketplace's February 11, 2015 notice continues in effect.

However, this dismissal does not affect notices that are sent subsequent to the appeal request.

If You Think Your Appeal Should Not Be Dismissed

Under some circumstances, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing you also must state a good reason for us to do this.

If you ask us in writing to vacate this dismissal, the Marketplace's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
