Dear [REDACTED],

On February 13, 2015, the Marketplace issued a notice for your child, [REDACTED] [REDACTED] stating that her coverage through Independent Health Association, Inc. is effective as early as March 1, 2015.

On March 2, 2015, you spoke to the Marketplace's Account Review Unit and requested an appeal insofar as your child's health coverage being effective March 1, 2015.

On March 24, 2015, the Marketplace issued a Notice of Telephone Hearing scheduling your hearing for April 20, 2015 at 2:00 pm.

On April 20, 2015, you failed to appear by telephone for your scheduled hearing. An impartial hearing officer attempted to contact you at the telephone number you provided on three separate occasions between 2:00 pm and 3:00 pm. However, no one answered. Therefore, we could not reach you.

Accordingly, we are dismissing your case.

How does this Dismissal Affect Your Eligibility?

The Marketplace's February 13, 2015 notice continues in effect.

If You Think Your Appeal Should Not Be Dismissed

Under some circumstances, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing you also must state a good reason for us to do this.

If you ask us in writing to vacate this dismissal, the Marketplace's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
