On January 8, 2015, the Marketplace issued a notice confirming you and your son's enrollment with your health insurance plan, effective February 1, 2015.

On March 17, 2015, you spoke with the Marketplace's Account Review Unit and appealed the effective start date of coverage for you and your son, insofar as it began on February 1, 2015, and not December 1, 2014.

On April 24, 2015, the Marketplace issued a Notice of Telephone Hearing to advise you that the hearing you requested was scheduled for May 15, 2015 at 9:00 a.m.

Between 9:00 a.m. and 9:45 a.m. on May 15, 2015, a Hearing Officer placed three calls to the telephone number that you gave the Marketplace, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The January 8, 2015 enrollment confirmation notice remains in effect.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
