Dear [REDACTED],

On March 19, 2015, the Marketplace issued a notice stating that you were eligible to receive advance premium tax credits of up to \$267.00 per month. Your eligibility was effective May 1, 2015.

On March 19, 2015, you requested an appeal regarding the March 19, 2015 eligibility determination.

On March 25, 2015, you called New York State of Health's Appeals Unit to withdraw your appeal. A Hearing Officer from the Marketplace's Appeals Unit received your call and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you did not want to pay premiums for the months where you did not have the opportunity to use your coverage.

Therefore, you withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 CFR § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

Your enrollment in your Fidelis plan will not be affected by the withdrawal of your appeal and will start as early as May 1, 2015 if you pay your share of the first month's premium promptly. The withdrawal of your appeal will not affect any determination issued after the March 18, 2015 notice.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
