NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear Ms. [REDACTED],

On March 10, 2015, the Marketplace issued a notice of eligibility determination based on your March 9, 2015 application. It said that you were eligible to enroll in a qualified health plan; eligible to receive an advance premium tax credit (APTC) of up to \$163.00 per month; and, if you selected a silver-level plan, eligible for cost-sharing reductions (CSR), effective April 1, 2015. You were also found eligible to enroll in a plan outside of the open enrollment period. However, you were found to be ineligible for Medicaid. This determination was based, in part, on an annual household income of \$35,717.50.

On March 23, 2015, you spoke with the Marketplace's Account Review Unit and appealed the March 10, 2015 eligibility determination insofar as you were eligible for an APTC of no greater than \$163.00 per month.

On March 27, 2015, the Marketplace issued a Notice of Telephone Hearing to advise you that the hearing you requested was scheduled for April 22, 2015 at 10:00 a.m.

On April 22, 2015, you failed to appear by telephone for your scheduled hearing. An impartial Hearing Officer attempted to contact you at the phone number you provided to the Marketplace on three separate occasions between 10:08 a.m. and 10:39 a.m. We were unable able to reach you.

Accordingly, we are dismissing your appeal.

The Marketplace's eligibility determination issued on March 10, 2015 remains in effect.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
