### NOTICE OF DISMISSAL - FAILURE TO APPEAR

On November 7, 2014, the Marketplace issued a renewal notice stating that you have been re-enrolled in Health Republic Insurance of New York with the start date of January 1, 2015.

On December 15, 2014, the Marketplace issued an enrollment confirmation stating that you have been enrolled in PrimarySelect Silver NS INN Dep25 Acupuncture with the premium responsibility of \$84.36.

On March 26, 2015, you spoke to the Marketplace Account Review Unit and requested an appeal insofar as you being renewed for health insurance through the Marketplace for 2015.

On April 11, 2015, the Marketplace issued a Notice of Telephone Hearing scheduling your hearing for April 30, 2015 at 3:00 pm.

On April 30, 2015, you failed to appear by telephone for your scheduled hearing. An impartial hearing officer attempted to contact you at the telephone number you provided on three separate occasions between 3:00 pm and 4:00 pm. You did not answer. Therefore, we were unable to reach you.

Accordingly, we are dismissing your case.

## How does this Dismissal Affect Your Eligibility?

The Marketplace's November 7, 2014 renewal notice and December 15, 2014 enrollment confirmation continue in effect.

However, any determinations made by the Marketplace subsequent to your appeal request will not be affected by this dismissal.

### If You Think Your Appeal Should Not Be Dismissed

Under some circumstances, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing you also must state a good reason for us to do this.

If you ask us in writing to vacate this dismissal, the Marketplace's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
