On March 28, 2015, the Marketplace issued an enrollment confirmation notice stating that your son's, [REDACTED], health insurance through Medicaid will begin November 1, 2014 and enrollment with UnitedHealthcare of New York, Inc. will begin May 1, 2015.

On March 30, 2015, you spoke to the Marketplace Account Review Unit and requested an appeal insofar as the effective date of your son's coverage with UnitedHealthcare of New York, Inc.

On May 8, 2015, you had a telephone hearing with a Hearing Officer from the Marketplace's Appeals Unit. At the hearing you confirmed that you no longer wanted to pursue your appeal and withdrew your appeal on the record through sworn testimony.

Accordingly, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The Marketplace's March 28, 2015 enrollment notice continues in effect insofar as your son's enrollment with UnitedHealthcare of New York, Inc. will begin May 1, 2015.

Any subsequent determinations made after the appeal request will not be affected by this dismissal.

If You Think Your Appeal Should Not Be Dismissed

Under some circumstances, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing you also must state a good reason for us to do this.

If you ask us in writing to vacate this dismissal, the Marketplace's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
