Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did the Marketplace properly determine that your enrollment in your Medicaid Managed Care plan should be effective June 1, 2015?

Procedural History

On April 24, 2015, an eligibility determination notice was issued stating that you are eligible for Medicaid effective April 1, 2015.

Also on April 24, 2015, the Marketplace issued an enrollment confirmation notice stating that your insurance coverage through Medicaid would begin "January 1, 2015" (*sic*) and your enrollment in your Medicaid Managed Care plan would begin June 1, 2015.

On May 6, 2015, you spoke to the Marketplace's Account Review Unit and appealed the enrollment confirmation notice insofar as it began your coverage under your Medicaid Managed Care plan on June 1, 2015.

On November 6, 2015, you had a telephone hearing with a Hearing Officer from the Marketplace's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) On April 23, 2015 you submitted an application to the Marketplace for health insurance and were found eligible for Medicaid based on the information contained in that application.
- 2) You selected a Medicaid Managed Care plan on April 23, 2015.
- 3) On April 24, 2015, the Marketplace issued a notice advising you that your Medicaid coverage began on January 1, 2015 and that the Medicaid Managed Care plan would take effect on June 1, 2015.
- 4) You testified that you want your Medicaid Managed Care plan to take effect on May 1, 2015.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

<u>Medicaid</u>

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Medicaid Managed Care (MMC) plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see §1115 Soc. Sec. Act; N.Y. Soc. Serv. Law §364-j(1)(c); 18 NYCRR 360-10.3(h)).

Legal Analysis

The issue is whether the Marketplace properly determined that your enrollment in your Medicaid Managed Care plan was effective June 1, 2015.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected between

the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

On April 23, 2015, you selected your Medicaid Managed Care plan, so it must take effect on the first day of the second following month after April; that is, on June 1, 2015.

Therefore, the April 24, 2015 enrollment confirmation notice stating that your Medicaid Managed Care coverage would take effect on June 1, 2015 is correct and must be AFFIRMED.

Decision

The April 24, 2015 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan is June 1, 2015.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to U.S. Department of Health and Human Services or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months after the date of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the U.S. Department of Health and Human Services. This must be done within 30 days of the date of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
