Dear [REDACTED],

On May 14, 2015 you spoke to the Marketplace's Account Review Unit and requested an appeal insofar as issues with your enrollment in a qualified health plan.

On June 23, 2015 the Marketplace issued an eligibility determination notice that you are eligible to receive up to \$218.00 per month of advance premium tax credits and cost-sharing reductions, if you enroll in a silver-level qualified health plan.

On the same day the Marketplace issued an enrollment notice confirming your enrollment in Univera Healthcare effective March 1, 2015.

On July 9, 2015 you had a telephone hearing with a Hearing Officer from the Marketplace's Appeals Unit. At the hearing you confirmed that you no longer wanted to pursue your appeal and withdrew your appeal on the record through sworn testimony.

Accordingly, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The Marketplace's June 23, 2015 notices continue in effect.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
