Dear [REDACTED],

On May 3, 2015 the Marketplace issued an eligibility determination notice that your spouse is not eligible for financial assistance and he cannot enroll in a qualified health plan at full cost through the Marketplace because he did submit proof of his citizenship status to confirm his eligibility.

On May 4, 2015 the Marketplace issued a disenrollment notice that your spouse's insurance through the Marketplace will end effective May 31, 2015.

On May 26, 2015 you spoke to the Marketplace's Account Review Unit and requested an appeal insofar as your spouse being disenrolled from his health insurance effective May 31, 2015.

On July 9, 2015 you had a telephone hearing with a Hearing Officer from the Marketplace's Appeals Unit. At the hearing you confirmed that you no longer wanted to pursue your appeal and withdrew your appeal on the record through sworn testimony.

Accordingly, we are dismissing your appeal.

### **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

If you ask us in writing to vacate this dismissal, the Marketplace's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by the Marketplace.
