## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

On June 16, 2015 the Marketplace issued a notice confirming that on June 15, 2015 you requested a telephone hearing. The notice verified that you had requested an appeal insofar as “requesting SEP to select a new dental plan but is not eligible.”

On October 21, 2015 the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 12, 2015 at 3:00 pm.

Between 3:00 pm. and 3:30 pm on November 12, 2015, a Hearing Officer from the Marketplace Appeals Unit attempted to contact you using the telephone number that you provided to the Marketplace, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
