Dear [REDACTED],

On July 3, 2015, the Marketplace issued a notice of eligibility determination, stating that your spouse was conditionally eligible to receive an advance premium tax credit of up to \$138.00 per month and cost-sharing reductions, effective August 1, 2015. You appealed this determination.

On July 18, 2015, the Marketplace issued a notice of eligibility redetermination stating that your spouse was eligible to receive an advance premium tax credit of up to \$212.00 per month and cost-sharing reductions, effective September 1, 2015.

On September 22, 2015, a Hearing Officer from the Appeals Unit of NY State of Health called you for the hearing you requested, and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you are satisfied with your spouse's current eligibility determination.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to Code of Federal Regulation (CFR) 45 CFR § 155.530(a)(1).

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
