## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did the Marketplace properly determine that you were eligible to receive up to \$148.00 per month in advance premium tax credit and, if you select a silver-level qualified health plan, eligible for cost sharing reductions, effective August 1, 2015?

Did the Marketplace properly determine that you were not eligible for Medicaid, effective August 1, 2015?

## Procedural History

On July 2, 2015, the Marketplace received your application for health insurance.

That same day, the Marketplace prepared a preliminary eligibility determination that you are eligible to receive up to \$148.00 per month in advance premium tax credits and, if you select a silver-level qualified health plan, eligible for cost sharing reductions, effective August 1, 2015, and not eligible for Medicaid.

Also, that same day you spoke with a representative from the Marketplace's Account Review Unit and appealed the preliminary determination insofar as you want a higher level of APTC or want to be redetermined eligible for Medicaid.

On July 3, 2015, the Marketplace issued a notice of eligibility determination that was consistent with the July 2, 2015 preliminary determination.

On October 8, 2015, after two adjournments, you and your authorized representative had a telephone hearing with a Hearing Officer from the Marketplace's Appeals Unit. Through sworn testimony, you agreed to waive formal notice of the hearing and to have, [REDACTED] your authorized representative speak on your behalf. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) Your authorized representative confirmed that you expected to file your 2015 taxes with a tax filing status of Single and will not be claiming any dependents on that tax return.
- 2) According to your Marketplace account, your Medicaid coverage through your local Department of Social Services ended effective July 31, 2015.
- 3) The application that was submitted on July 2, 2015 listed an annual household income of \$25,361.93, consisting of \$9,745.93 you earned from your former employment with [REDACTED] and \$15,616.00 you expect to earn from your current employer, [REDACTED]. You testified that these amounts were correct.
- 4) You testified that your current gross monthly income is approximately \$2,230.00.
- 5) Your application states that you will not be taking any deductions on your 2015 tax return. Your authorized representative confirmed that this was correct.
- 6) Your authorized representative testified that you cannot afford to pay for health insurance given your monthly basic living expenses, such as rent, utilities, transportation, and food.
- 7) Your application states that you live in Erie County, New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Advance Premium Tax Credit

The advance premium tax credit (APTC) is generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household

income between 138% and 400% of the applicable poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

*minus*

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2015 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc. 2014-37).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2014 FPL, which is \$11,670.00 for a one -person household (79 Fed. Reg. 3593, 3593).

For annual household income in the range of at least 200% but less than 250% of the 2014 FPL, the expected contribution is between 6.34% and 8.10% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2014-37).

### Cost Sharing Reductions

Cost sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through the Marketplace, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

### Medicaid

Medicaid can be provided through the Marketplace to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted

gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), N.Y. Soc. Serv. Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2015 FPL, which is \$11,770.00 for a one-person household (80 Fed. Reg. 3236, 3237).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

### Modified Adjusted Gross Income

The Marketplace bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, and deductions attributable to royalties (26 USC § 62(a)). Living expenses, such as rent, utilities, transportation, and food, are not an allowable deductions in computing adjusted gross income.

### Affordability Exemption

Under some circumstances, a person may receive an exemption from paying a penalty for not purchasing health insurance coverage. Such an exemption may be granted if that person can show that he or she experienced a financial hardship or has domestic circumstances that (1) caused an unexpected increase in essential expenses that prevented that person from obtaining health coverage under a QHP; (2) would have caused the person to experience serious deprivation of food, shelter, clothing, or other necessities, as a result of the expense of purchasing health coverage under a QHP; or (3) prevented that person from obtaining coverage under a QHP (45 CFR § 155.605(a), (g)).

NY State of Health has deferred to the U.S. Department of Health and Human Services (HHS) on the matter of hardship exemptions (see 45 CFR § 155.505(c)).

## Legal Analysis

The first issue is whether the Marketplace properly determined that you were eligible for an advance premium tax credit (APTC) of up to \$148.00 per month.

The application that was submitted on July 2, 2015 listed an annual household income of \$25,361.93, and the eligibility determination relied upon that information.

You are in a one-person tax household. This is so because you expect to file your 2015 income taxes as Single and will not be claiming any dependents on that tax return.

You reside in Erie County, where the second lowest cost silver plan available for an individual through the Marketplace costs \$295.03 per month.

An annual income of \$25,361.93 is 217.33% of the 2014 Federal poverty level (FPL) for a one-person household. At 217.33% of the FPL, the expected contribution to the cost of the health insurance premium is 6.95% of income, or \$146.87 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through the Marketplace for an individual in your county (\$295.03 per month) minus your expected contribution (\$146.87 per month), which equals \$148.16 per month. Therefore, rounding to the nearest dollar, the Marketplace correctly determined you to be eligible for up to \$148.00 per month in APTC.

The second issue is whether you were properly found eligible for cost sharing reductions. Cost sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$25,361.93 is 217.33% of the applicable FPL, the Marketplace correctly found you to be eligible for cost sharing reductions.

The third issue is whether the Marketplace properly determined that you were ineligible for Medicaid.

Medicaid can be provided through the Marketplace to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,770.00 for a one-person household. Since \$25,361.93 is 215.48% of the 2015 FPL, the Marketplace properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

The same would be true on a monthly basis, since the maximum amount of allowable income for Medicaid is 138% of the FPL, which equals \$1,354.00 per month. Your reported monthly income is currently \$2,230.00, which exceeds the maximum allowable monthly income limit. Therefore, you are not eligible for Medicaid based on your current monthly reported income.

Since the July 3, 2015 notice of eligibility determination properly stated that, based on the information you provided, you were eligible for up to \$148.00 per month in APTC, eligible for cost sharing reductions, and ineligible for Medicaid, it is correct and is AFFIRMED.

If you wish to be considered for a hardship exemption, which would exempt you from paying a penalty for not having health insurance during 2015, you can check the Federal Marketplace website ([www.healthcare.gov](http://www.healthcare.gov)) for direction.

## **Decision**

The July 3, 2015 notice of eligibility determination is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You remain eligible for up to \$148.00 per month in advance premium tax credits and, if you select a silver-level qualified health plan, eligible for cost sharing reductions, effective August 1, 2015.

You remain ineligible for Medicaid.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to U.S. Department of Health and Human Services or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months after the date of the Decision Date, which appears on the first page of this Decision.

This must be done within 30 days of the date of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

The July 3, 2015 notice of eligibility determination is **AFFIRMED**.

You remain eligible for up to \$148.00 per month in advance premium tax credits and, if you select a silver-level qualified health plan, eligible for cost sharing reductions, effective August 1, 2015.

You remain ineligible for Medicaid.
