NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On February 7, 2015, the Marketplace issued an enrollment notice confirming that you, your spouse and children were enrolled in UnitedHealthcare of New York, Inc. and coverage will begin March 1, 2015. You appealed this determination.

On August 19, 2015, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for September 18, 2015 at 9:00 am.

Between 9:00 am. and 9:30 am on September 18, 2015, a Hearing Officer from the Marketplace Appeals Unit attempted to contact you three times using the telephone number that you provided to the Marketplace. On the third attempt an unidentified man answered, stated “call back at 10”, and terminated the call. Three attempts were made to contact you at the set date and time of the scheduled hearing.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
