NOTICE OF DISMISSAL – FAILURE TO APPEAR

On July 11, 2015, the Marketplace issued an enrollment confirmation notice stating that you and your spouse's enrollment in a qualified health plan is effective August 1, 2015. You appealed this determination.

On September 9, 2015, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for October 9, 2015 at 1:00p.m.

Between 1:00p.m. and 1:30p.m. on October 9, 2015, a Hearing Officer placed three calls to the telephone number that you have provided to the Marketplace. On the third call the Hearing Officer spoke to your spouse who stated you were not available to take the call. The Hearing Officer agreed to send your case back for reschedule for another date and time.

On October 9, 2015, the Marketplace issued a Notice of Hearing to advise you that your hearing was rescheduled for October 30, 2015 at 9:00a.m.

At 9:00am on October 30, 2015, a Hearing Officer placed a call to the telephone number that you have provided to the Marketplace. The Hearing Officer spoke to your spouse who stated you were not available to take the call.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
