## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On July 19, 2015, the Marketplace issued a notice of eligibility determination that your spouse was no longer eligible for financial assistance and could not be enrolled in a qualified health plan at full cost through the Marketplace. That same day, the Marketplace issued a disenrollment notice that her coverage with Fidelis Care Silver will end effective July 31, 2015. You appealed this determination and you spouse's disenrollment from her health plan through the Marketplace.

On September 24, 2015, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for October 13, 2015 at 10:00 a.m.

Between 10:00 a.m. and 10:30 a.m. on October 13, 2015, a Hearing Officer placed three calls to the telephone number that you have provided to the Marketplace, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
