On July 19, 2015, the Marketplace issued an eligibility determination notice and enrollment notice regarding your daughter's Child Health Plus eligibility and enrollment, effective September 1, 2015. You appealed this determination and enrollment start date.

On November 12, 2015, a Hearing Officer from the Appeals Unit of NY State of Health called you to conduct a formal telephone hearing and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you did not incur any medical expenses for your daughter during August 2015 and coverage for that month is now moot.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to Code of Federal Regulation (CFR) 45 CFR § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
