## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On August 26, 2015, the Marketplace issued a notice confirming the enrollment of your two children, [REDACTED], in an EmblemHealth Child Health Plus (CHP) plan on August 25, 2015, at a total premium of \$30.00 per month. This notice further stated that coverage for your children could begin as soon as October 1, 2015 if you paid your first month's premium. You appealed this notification insofar as you were seeking a coverage start date of September 1, 2015.

On December 9, 2015, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your children did not incur any out-of-pocket medical expenses during September 2015, and so a backdate of your children's CHP coverage was no longer necessary.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to Code of Federal Regulation (CFR) 45 CFR § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
