Dear [REDACTED],

On September 5, 2015, the Marketplace issued a notice of eligibility determination stating your spouse was no longer eligible for financial assistance and could not enroll in a qualified health plan, effective September 30, 2015. That same day, the Marketplace issued a disenrollment notice that your spouse's enrollment would end September 30, 2015. You appealed this determination and your spouse's disenrollment.

On January 8, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you to conduct a formal hearing and placed you under oath.

While under oath and with the assistance of a Spanish Interpreter (ID # [REDACTED]) you identified yourself and stated you were no longer interested in pursuing your appeal because October 2015 had passed and your spouse currently had the health insurance she needed.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to Code of Federal Regulation (CFR) 45 CFR § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
