NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On October 17, 2015, the Marketplace issued a disenrollment notice stating that your child's coverage under her Child Health Plus plan would end October 31, 2015. On October 22, 2015, the Marketplace issued notices of eligibility redetermination and enrollment that respectively stated your child was (1) eligible to enroll in a full price CHP plan or Child-Only qualified health plan, effective December 1, 2015; and (2) enrolled in the CHP plan you selected, effective December 1, 2015. You appealed your child's gap in coverage during November 2015.

On January 13, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you to conduct a formal hearing and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you did not believe you had incurred any medical expenses for your child's care during November 2015 and were now satisfied with the December 1, 2015 start date of her Child Health Plus plan coverage.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to Code of Federal Regulation (CFR) 45 CFR § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
