## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On November 25, 2015, based on your November 16, 2015 Medicaid Managed Care (MMC) plan selection, the Marketplace issued an enrollment notice confirming that your MMC plan would start, effective January 1, 2016. You appealed that enrollment start date and wanted your MMC plan coverage backdated to November 1, 2015.

On January 8, 2016, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 4, 2016, at 10:00 a.m.

Although an entry to the Marketplace's records suggests that you had an authorized representative whom you wanted to speak on your behalf, no signed authorized representative form was in your Marketplace account as of the date of your hearing.

Therefore, on February 4, 2016, a Hearing Officer placed four calls to the telephone number that you provided to the Marketplace [REDACTED], at 10:01 a.m., 10:03 a.m., 10:05 a.m., and 10:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
