## NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On June 16, 2015, the Marketplace redetermined your household's eligibility and found your newborn child eligible to enroll in the household's qualified health plan (QHP), effective August 1, 2015. You appealed this determination as you believed that your newborn child would be added to the health plan effective July 1, 2015. Thereafter, the Marketplace remedied the situation by backdating your newborn child's health insurance coverage in your household's QHP to July 1, 2015.

On January 15, 2016, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 8, 2016, at 11:00 a.m.

On February 8, 2016, a Hearing Officer placed three calls to the telephone number that you provided to the Marketplace, at 11:00 a.m., 11:09 a.m., and 11:32 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

**If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
