NOTICE OF DISMISSAL – FAILURE TO APPEAR

On December 6, 2015, the Marketplace issued a notice of eligibility determination, stating that you were eligible for advance premium tax credits of \$0.00 per month, effective January 1, 2016. You appealed this determination.

On December 31, 2015, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for January 29, 2016, at 10:00 AM.

At 10:00a.m. on January 29, 2016, a Hearing Officer attempted to reach you twice at the telephone number that you provided to the Marketplace, but received a message that the number was not in service. The Hearing Officer also attempted to reach you twice on the cell phone number listed in your account, but received a message that the number was not valid.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
