On December 31, 2015, the Marketplace issued a notice of enrollment, stating that your children's Child Health Plus plan was effective February 1, 2016. You appealed this determination.

On February 29, 2016, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 28, 2016, at 11:00a.m.

On March 28, 2016, a Hearing Officer placed a call to you and you requested that your hearing be adjourned until April 1, 2016 at 10:00a.m. You also requested that the Hearing Officer call you at your home phone number.

On April 1, 2016 at 10:00a.m, a Hearing Officer placed a call to your home phone number, however you were not at home and the Hearing Officer was advised to call your cellphone. The Hearing Officer placed three calls to your cellphone number, at 10:00a.m., 10:15a.m., and 10:30a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
