NOTICE OF DISMISSAL

On January 9, 2016, the Marketplace issued an enrollment confirmation notice. You appealed this notification.

On March 18, 2016, the Marketplace issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 14, 2016, at 3:00 p.m.

A Hearing Officer called you at 3:11 p.m. on April 14, 2016. You answered the call and stated that you no longer wanted to proceed with the appeal since your son did not incur any medical expenses during the month of January 2016. The Hearing Officer asked to swear you in, in order to obtain a proper withdrawal over the telephone. You stated that you did not have time and requested the Hearing Officer just cancel the appeal since it was no longer needed.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

The Marketplace's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, the Marketplace will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
