Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible to receive up to \$251.00 per month in advance payments of the premium tax credit, effective March 1, 2016?

Did NY State of Health properly determine that you were eligible for cost-sharing reductions provided you select a silver-level qualified health plan, effective March 1, 2016?

Did NY State of Health properly determine that you were not eligible for Medicaid?

Procedural History

On January 25, 2016, NY State of Health (NYSOH) received your completed application for health insurance and prepared a preliminary eligibility redetermination finding you eligible to receive up to \$251.00 per month in advance payments of the premium tax credit (APTC) and, if you select a silver-level qualified health plan, eligible for cost sharing reductions, effective March 1, 2016.

Also on January 25, 2016, you contacted NYSOH's Account Review Unit and requested an appeal of that preliminary eligibility determination insofar as you were not determined eligible for Medicaid. You also requested that your aid continue under Medicaid during the appeal process, which was granted by

NYSOH per the April 20, 2016 notices of eligibility redetermination and enrollment, with an effective date of February 1, 2016.

On January 26, 2016, NYSOH issued an eligibility redetermination notice that was consistent with the January 25, 2016 preliminary redetermination. That notice also stated that you were not eligible for Medicaid because your reported household income of \$24,192.00 was over the maximum allowable income limit for this program.

Also on January 26, 2016, NYSOH issued an enrollment notice confirming your enrollment in a silver-level qualified health plan with a monthly premium of \$258.26 after your monthly APTC of \$251.00 was applied and an enrollment start date of March 1, 2016.

On May 19, 2016, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2016 federal taxes with a tax filing status of single and will not claim any dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on January 25, 2016 listed annual household income of \$24,192.00, consisting of \$15,540.00 in Social Security Title II benefits and \$8,652.00 in pension and annuities. You testified that these amounts was correct.
- 4) You testified that your monthly income for each month in 2016 is approximately \$2,000.00. According to your NYSOH account, your monthly income is listed as \$2,016.00.
- 5) Your application states that you will not be taking any deductions on your 2016 tax return. You testified that this is correct.
- 6) Your application states that you live in Orange County, New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2016 is set by federal law at 2.03% to 9.66% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc. 2014-37, IRS Rev. Proc. 2014-62).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2015 FPL, which is \$11,770.00 for a one-person household (80 Fed. Reg. 3236, 3237).

For annual household income in the range of at least 200% but less than 2015% of the 2015 FPL, the expected contribution in 2016 is between 6.41% and 8.18% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2014-37, IRS Rev. Proc. 2014-62).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may

get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), N.Y. Soc. Serv. Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, January 25, 2016, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue is whether NYSOH properly determined that you were eligible for an APTC of up to \$251.00 per month.

The application that was submitted on January 25, 2016 listed an annual household income of \$24,192.00 and the eligibility redetermination relied upon that information.

You are in a one-person household. This is because you expect to file your 2016 income taxes as single and will not claim any dependents on that tax return.

You reside in Orange County, where the second lowest cost silver plan available for an individual through NYSOH costs \$384.49 per month.

An annual income of \$24,192.00 is 205.54% of the 2015 FPL for a one-person household. At 205.54% of the FPL, the expected contribution to the cost of the health insurance premium is 6.61% of income, or \$133.26 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$384.49 per month) minus your expected contribution (\$133.26 per month), which equals \$251.23 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$251.00 per month in APTC.

The second issue is whether you were properly found eligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$24,192.00 is 205.54% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

The third issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since \$24,192.00 is 203.64% of the 2016 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

The same is true using your monthly income of \$2,016.00. To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,367.00 per month. Since the record reflects that you have a consistent monthly income of \$2,000.00 to \$2,016.00, you do not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the January 26, 2016 eligibility redetermination notice properly stated that, based on the information you provided, you were eligible for up to \$251.00 per month in APTC, eligible for cost-sharing reductions, and ineligible for Medicaid, it is correct and is AFFIRMED.

Decision

The January 26, 2016 eligibility redetermination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for up to \$251.00 per month in APTC.

You are eligible for cost-sharing reductions.

You are ineligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to U.S. Department of Health and Human Services or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the U.S. Department of Health and Human Services. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

If you wish to be represented by an attorney in bringing an outside appeal and do not know how to go about getting one, you may contact legal resources available to you. You may, for example, contact the local County Bar Association, Legal Aid, or Legal Services.
