On January 31, 2016, NY State of Health (NYSOH) issued a notice of eligibility redetermination confirming that you and your spouse remained eligible for Medicaid. On that same date, NYSOH issued an enrollment confirmation notice stating your household's coverage with your Medicaid Managed Care plan would remain the same with a plan enrollment start date of March 1, 2015. You appealed that determination.

On June 21, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because the issue had resolved itself.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
