NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On February 18, 2016, NY State of Health (NYSOH) issued notices of eligibility redetermination and enrollment, which stated respectively that you were eligible for Medicaid, effective February 1, 2016, and your start date of the Medicaid Managed Care plan you selected was April 1, 2016. You appealed that start date.

On June 3, 2016, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for July 19, 2016, at 10:00 a.m.

On July 19, 2016, a Hearing Officer placed two calls to the telephone number that you provided to NYSOH, at 10:00 a.m. and 10:01 a.m., but got a facsimile signal each time. The Hearing Officer then placed three calls to the cellular number listed on your NYSOH account at 10:03 a.m.; 10:07 a.m.; and 10:32 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
