NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On January 20, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your family was eligible for advance premium tax credits and cost sharing reductions for your qualified health plan effective March 1, 2016. You appealed that determination.

On July 11, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called and spoke with [REDACTED]. The Hearing Officer placed [REDACTED] under oath.

While under oath, she identified herself and stated that you were no longer interested in pursuing your appeal because you had earlier contacted the NYSOH and withdrew the appeal.

[REDACTED] withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
